## **Public Comment:**

Scott Briggs asked regarding the Sutter Road access. Lon said he spoke with Heidi Shaffer and there are some proposed changes. She proposed reducing the catch basin. She also proposed to put catch tiers on the south side where the water actually flows. Briggs asked about the docks being stored on the access? Weinzapfel said he will discuss it with the owner when he returns, and make sure the docks are not on the access property in the future.

Dennis McQuillan asked how many public accesses? Weinzapfel has a list of all of the access sites and their use. He will provide that to McQuillan.

Tom Paradis asked regarding the progress on Maplehurst. Bargy said the grant went through. We are still looking at 1-2 years before it becomes the township's property. The conservancy still needs to raise \$1.8 million over and above the grant. They will fence around the lodge shortly. They are going to put a better gate up to keep people out.

Cal Nagy said he'd like to see a timeline of events and how things will happen. If it does go public, is there any way the township can compensate neighboring property owners for their property rights. Nagy has water and fishing rights to the lake and he's wondering about compensation.
