Discussion of letter regarding sewer easement: Trinity K Real Estate LLC. Plan to schedule a meeting date for both parties and legal, to discuss options for a resolution.

Supervisor's Report

Through a MDEQ grant and the Tip of the Mitt Watershed Council, Milton Twp., has been offered a cost sharing proposal to install a greenbelt at the Waterfront Park. After discussion, Cole suggested that the shoreline protection subcommittee meet with Parks and Rec to discuss options.

Estimate from Sound and Video Systems to upgrade our receiver and install a new camera \$1629.50. Cole asked if the new camera was equipped to record at night. Bargy stated that there would be added lighting. Motion to approve by Atkinson/Pharo. Motion carried.

Otto Scherf submitted a letter inquiring about yard waste disposal.

Milton Township will have the second cleanup day on Saturday August 26th 7:00 am to 12:00 noon.

Campbell was resurfaced. Paving should begin the end of August/first of September.
