**Motion** by Kingon to schedule a public hearing which will provide new definitions for Chapter 2 regarding Earth Change, Pervious, and Pervious Surface, reference Draft 7.10.17. Seconded by Kopkau. **Motion carried**.

### 4. Weltyk Special Use 2018-01-SU.

Weinzapfel gave an overview of the request. Members reviewed the application. He is looking for a Special Use permit under 117.305A4 as the square footage of the accessory structure will exceed his primary structure in the R1 district. Murphy asked if he will provide us with a survey. They are still two platted lots. They would be merged for purposes of zoning. If he wanted to split them, he would have to come before the township board for approval. He must adhere to the lot coverage regulations of 40%. Merillat suggested going through a site plan review which would be appropriate for a subcommittee. Lefebvre asked if it had to go to a public hearing next month. No. Lefebvre recommended doing the subcommittee and the Site Plan Review.

Subcommittee will be Merillat, Kopkau, and Murphy. They will meet April 3rd at 9:00am.
