Public Comment:

Karen Bargy gave the county commissioner's report. She presented a pamphlet on services from the health department. These are available at the Milton Twp., office. A report was given on Commission on Aging. There are vacancies on numerous boards. Anyone interested, can go to the County webpage for details. There is discussion on forming an Ad hoc committee to gather input on the County's Facility Master Plan. She would like to see this side of the county represented as well.

As a citizen of the township, K. Bargy said they are applying for a grant through rural development to develop seasonal workforce housing on their property.

Motion by Atkinson/Pharo to provide a letter of support to K. Bargy for their grant application. Motion carried.

Brad Muma of Performance Engineering gave a report on identifying preliminary budget numbers for the sewer line extension. A list of potential residents and business owners have been provided, with # of REU's and connection fees. There is a Tie-in cost estimate sheet as well. These are not firm numbers. Total estimate cost for project \$205,701.

A letter will be drafted and sent to everyone along the proposed pipeline section.

Sheriff's Report: Submitted. 91 events for October.

Fire Department Report: Chief J. Ball

2 events for October. 62 runs for the year. At this time last year, we had 70. Update on mutual aid agreement with the Grand Traverse Band. We are invited to do presentation for Elk Rapids Rotary regarding the department and services provided to Milton Township. There is a recall on the new truck. Discussion regarding trees on lines with Frontier and Charter. We have an offer on 9940 for \$20K. I counter offered for \$25K and \$23K. Both offers were declined.

Pharo said he can see additional restrictions are necessary. Atkinson said she's in favor or limiting it to four weeks per year. Ball said the original intent was to help defer cost so people could keep the family cottage. Not to run a commercial business.

A special use permit was approved for North Shore Dock for marine sales, service, and repair. Tomorrow we will be discussing subcommittee reports.
