1. Vacation Rentals Subcommittee:

A subcommittee meeting was held yesterday morning, April 8, 2019. Kingon discussed the meeting and said perhaps we should consider exemptions by zone because of some feedback received from an attendant at the subcommittee meeting. The main activity was to review comments received from Brett Pharo. Kingon discussed Pharo's comments point by point. Kingon has updated the document per the comments and has provided Draft 8 for review. If we exempted the village, people could buy land on the water and build a big lodge and rent it out daily. Motels are allowed in the Village zone. Kingon suggested a way to create the exemption.

The number of weeks is the issue for the village zone. Hefferan suggested having an additional subcommittee meeting to address this for the sake of thoroughness and transparency with the public.

Kingon said there is a company in California called Host Compliance that is reviewing the ordinance. Their business is to work with local governments regarding short term rentals. Their services are rental activity monitoring, among other things. Through software, they are able to look at 120 different rental sites advertisements and identify them by address. We currently have 10-12 permits for rental, but they showed us that they found more than 50 rentals available in Milton Township. They also have a compliance monitoring system helps with those who are advertising but without permits. Kingon, Weinzapfel, and a couple of Township Board members will meet with Host Compliance for follow-up on April 18th.

Suttons Bay has been using this company and they also have a rental ordinance similar to ours. Weinzapfel will discuss how it has been going with Suttons Bay.

The next subcommittee meeting is to be scheduled later.
