Synopsis Milton Township Meeting Minutes November 9, 2020

This meeting was held via teleconference on Nov. 9, 2020 due to Covid-19

Bargy called the meeting to order at 7 pm.

Agenda Approval by consent.

Approval of regular meeting minutes of October 12, 2019 Motion to approve by Atkinson/Cole. Motion carried.

Public Comment:

Tony Wittbrodt of Elk Rapids is speaking on the Friends of the Library Board. He addressed some of the issues that are being discussed between The Friends of the Library Board and the Elk Rapids Library. An audit has been agreed to by The Friends and The Elk Rapids Library. We want to assure the public we are fully cooperating.

Fred Gulick of E. Elk Lake Drive: Said that there wasn't proper notice given of this meeting. He believes the township is in violation of open meetings act. Mac Whitehouse of Wabigama Dr., discussed outdoor storage of boats and trailers that are being stored in a way not in accordance with the zoning ordinance on Jim Brewer's property.

Karen Simpson with the Elk Rapids District Library Board spoke about the challenges on the Library Board and how it has brought out the best of the community as well as its support.

Kelly Wells discussed her comments at last month's meeting. She hasn't heard back and is looking for the update on this. Bargy said EGLE is reporting to the county and Milton has no say over this. It is not on the Planning Commission agenda for tomorrow night.

Brenda Hasso of Torch River Rd said in regards to the proposed RV Park, there is a lot of back and forth over who is taking ownership of the problem. Who is responsible? What is the update on this issue? Bargy said it's in the restoration phase and it will be coming back to the planning commission at a future date.

The Village of Elk Rapids is requesting a meeting with Elk Rapids Twp., and Milton Twp., to discuss the District Library Agreement.

There was discussion on doing an audit of the Library Funds. Since there has already been an audit, it was proposed to do a Financial Review.

The Record Eagle has put in a FOIA request to the ERDL.

Fred Gulick of E. Elk Lake Drive further discussed the violation of the open meetings act and the matter with the county equalization.

Mac Whitehouse of Wabigama Dr., discussed the RV park remediation. No one is taking responsibility. Please work with Antrim County to clarify authority and make sure nothing falls between the cracks.

Bargy said there has been discussion of the township hiring its own environmental consultant. This is just in the discussion phase right now.
