Public Comment:

Jim McKimmy said in Sept. 2019 there was a discussion of proceeding with a sewer. We understood that if 50% of an area agreed to proceed, then the township would proceed with a feasibility study. A group came together and solicited signatures on a petition from Elk Tip to Easley. This was submitted to the clerk and supervisor.

McKimmy read the petition and discussed the properties. He asked that this item be discussed further and move forward with a feasibility study.

Pharo and Atkinson discussed and how best to proceed. McKimmy discussed the history of his meetings with Lon Bargy. They discussed how parcels were determined.

Brad Muma said the percentage of signatures is being considered as a requirement. The feasibility study doesn't have a signature requirement unless you require one. Muma said he presented some costs in July of 2020. Costs will be different today. Atkinson asked if it's normal to spend tax dollars without getting public approval. Muma said with this signature list, it shows interest. Municipalities spend public dollars all the time without a vote on each dollar.

Ball said she'd like to have a policy that would set the parameters of doing a feasibility study, for now and the future. Pharo said he doesn't think we would be setting a precedent by doing a feasibility study. We can decide to do it or not.

Muma said a feasibility study is going to give you information and numbers to discuss with your residents.

Carolyn Sinnel of Ridge Road said she's in favor of the feasibility study and she'd like to hear what the next steps are.

Jim McKimmy said, Townships that are shovel ready, will have a leg up on getting available funds. Be ready for your future expenditures.

Fred Gulick said, he's not in favor of a sewer system unless there is a vote of the people. He also has concerns about the time of transfer septic ordinance.

Muma discussed what a failed sewer system is and what are zoning issues.

Approval of Bills:
