Discussion of bids for installation of a gravel pad to conduct training at station 2. It was sent to six companies and we ended up with three. Drogt's was the lowest bid. S. Ball asked regarding the cleanup for fluids. J. Ball said its Afton stone. This should work better overall.

Regarding Waring Road access. The county did agree to deed the 50 feet of lot 1 to Milton Township. Update on the ER District Library. The village and township are down to negotiating a property transfer agreement. I recommend the board approve the Metro application submitted by 186network/Coli. That makes it so they are allowed to use the public roads in Milton Township. Authorize L. Bargy to sign it. Regarding 186 Networks, we are on our 4th draft of the agreement. I discovered something I didn't know. I'm going to request the board have a special meeting to discuss this application. The board will set a special meeting to discuss with 186 Networks. We will set a special meeting Wednesday September 14<sup>th</sup>, at 10:00 a.m. to finalize the agreement.

Derman said he would like the authority to approve the Metro Act Permit Application. In addition, approve L. Bargy to sign the agreement. Motion to approve the Metro Act Permit Application by B. Pharo/L. Atkinson. Motion carried Roll call: L. Bargy – Yes; B. Pharo – Yes; L. Atkinson – Yes; and S. Ball – Yes. Motion carried 4-0

## **Supervisor's Report**

L. Bargy discussed signage at the O'Dell Road access. It is a water point access according to J. Ball. We just got the permit for the ramp this week.

Bargy said the company contracted to do the siding on the Old Town Hall are waiting on materials.

L. Atkinson said we need to appoint a trustee tonight. The recommendation is for Joe Renis.

Motion to appoint Joe Renis as the new Township Board Trustee for Milton Township by L. Atkinson/B. Pharo. Motion carried. 4-0

**A.** Letter from Waterfire Vineyards

Chantel Lefebvre and her husband Mike Neuman are the owners of Waterfire Vineyards. We have appealed to the township that we do not fit into the STR ordinance which was established for the residential community. We had been working with the planning commission to put together a revised ordinance for wineries but we ran into four different drafts. We retreated from that process then, but we are now asking for a reprieve from being limited from renting our place. We would like to work with the planning commission.

Pharo said he agrees with Lefebvre. He doesn't think Ag tourism is what we were looking at with short term rentals. Atkinson said the way it's written, Kopriva did her due diligence and that's why the letter went out. Lefebvre said they will be appealing.

Hefferan said we received an application to review our ordinance. The applicant withdrew their application. Anyone can file a request for us to revisit our ordinance. If Waterfire wants us to revisit our ordinance, they can file a request.

### **Public Comment**

Joyce Grammar spoke in favor of the winery's request.

Lefebvre said we are still the only vineyard in Milton Township. Why put the road blocks up before you need to? There are no problems. The ordinance is very restrictive.

Petersen asked the board how to proceed with the violation. Bargy said to let it go until we sort it out. Atkinson said the violation should remain. Ball said you cannot pick and choose, follow the ordinance. This will be referred to the zoning department.
